REQUIRED FEE: You must pay a \$35 fee when submitting this application. The Court may waive or reduce the fee if you cannot pay the entire fee. If the fee is not waived and you do not pay the fee, the amount will be added to any costs you are ordered to reimburse at the conclusion of your case.

NOTICE: You may be required to submit verification of your gross income. Verification of gross income includes one of the following:

- 1) most recent pay stub reflecting current wages, or
- 2) most recent W-2, or
- 3) most recent tax return, or
- 4) written statement from employer.

All questions must be answered, or the application will be denied, answers with zeros, slashes, or n/a are not accepted.
